In year 2020-21, Covid-19-virus invaded our world, enveloping us with uncertainty. It is at times like these, that we at the India Vision Foundation turn to our communities for hope. We Revived, Restore and Reintegrated by adopting following strategies.

Ideate – Innovate – Adapt: An exhaustive study was commissioned by the foundation through a reputed external agency to identify new emerging needs due to the Pandemic. Our learnings indicated access to Daily Essential, Hygiene Kits in addition to Mental wellness needs. Project Annapurna & Kaurna was conceptualized primarily to address these issues. We distributed over **27637** Hygiene Kits inside Prison across Delhi NCR Region. For our children beneficiaries, we invested in over **2400** hours of Virtual Sessions.

Leveraging Technology: We continued to leverage Technology and Digital space for our interventions through Web meetings, e-Contents, Cloud computing, UPI, etc. The staff of the foundation was upskilled through – Do It Yourself / Virtual Training sessions.

Trust & Transparency & Accountability : Trust, transparency and accountability forms integral part of the foundation's DNA. We continued our commitment to our donors & beneficiaries through a clear line of communication. 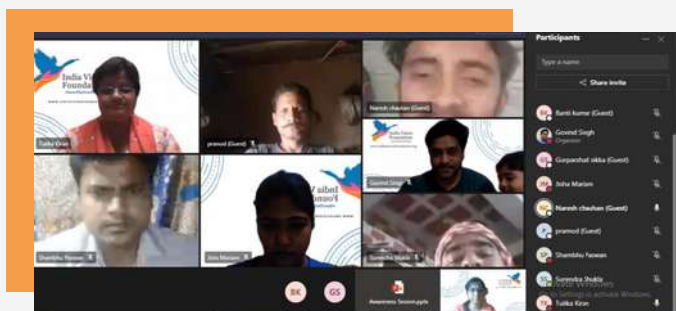

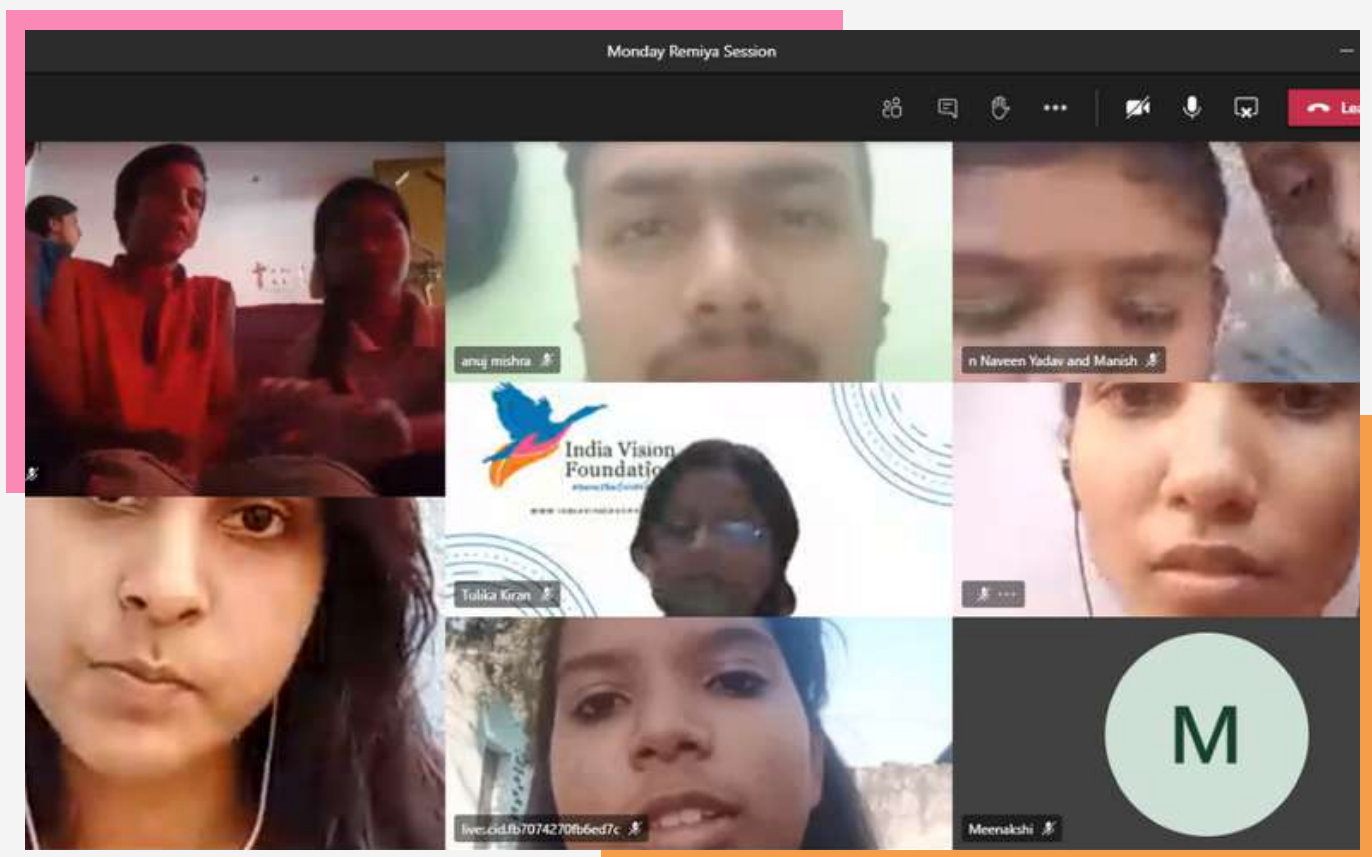

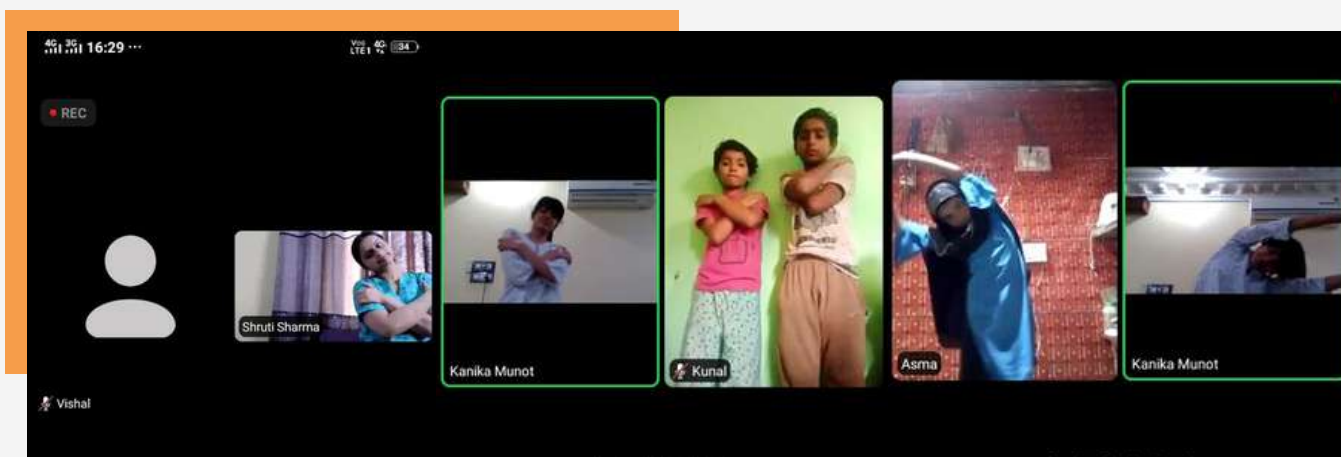

Children- our young beneficiaries continued to be our priority and all efforts to keep them happy, healthy, and engaged continued through regular contact with their family on their mobiles. Virtual classes became a norm, and all children excitedly wait for new activities that are introduced for their interest every day through the Children of Vulnerable Families (CVF) Program.



With a network of more than 60+ Volunteers and interns, there was a mosaic of activities, events, and creative learning opportunities both for the children as well as their parents. The involvement of parents in the learning process resulted in close bonding within the families and with the project team members.

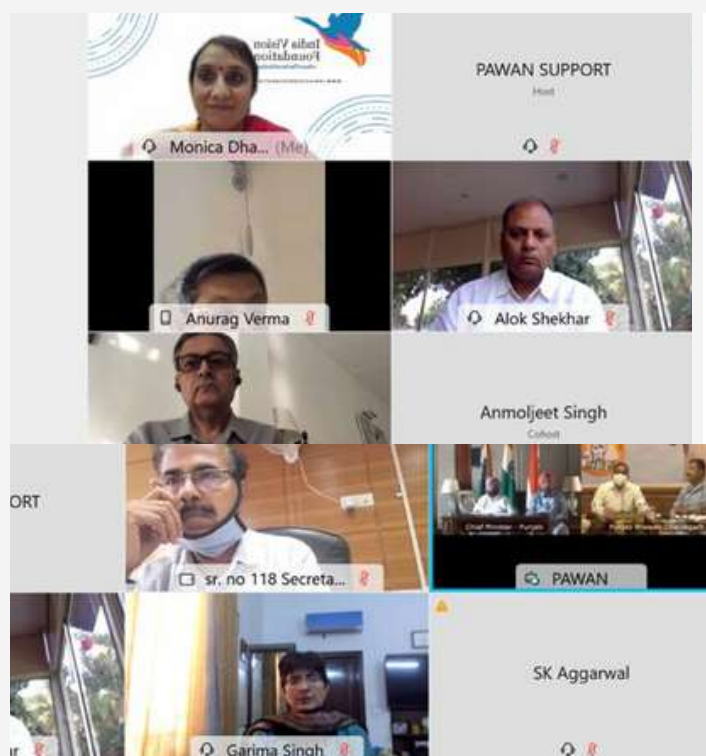

Launch of Audio E-content

Total **16** E-Audio content on various topics was prepared and shared with prison administrations across different prison sites for the benefit of incarcerated inmates during the pandemic.

In order to provide psychological assistance to inmates inside the prison who are battling with stress, anxiety, and depression Foundation partnered with Dr. Pinki Goswami, Psychologist, who provided inmates with counseling & therapy support through monthly visits to Faridabad, Gurugram & Kasna prison's male & female

ward. The project has extended support to 45 male inmates & 10 female inmates across Haryana & UP Prisons.

Project Sampark

Connecting with empathy, a first-of-its-kind virtual interaction was held on 3rd November 2020 by the India Vision Foundation team with the 18 female inmates of Ambala Prison through Virtual



Conferencing Facility within the prison. The Counselling Session as aimed to understand the issues of the female inmates of Ambala Prison so as to plan future interventions as per the mutually identified needs.

Inauguration of Online Counselling & Prison Inmate Calling System (PICS)



India Vision Foundation in collaboration with Haryana Prisons & Karma Centre for Counselling and Wellbeing launched its first of its kind Online Counselling & Prison Inmate Communication System in the presence of Dr. Kiran Bedi, Lt. Governor Puducherry, Mr. Ranjit Singh, Hon'ble Minister of Power & Prisons, Haryana, Shri Rajeev Arora IAS, ACS, Home & Jail Department, Haryana, Shri Selvaraj, Director General of Prisons, Haryana, Mr. Harinder Singh, Superintendent Haryana Prisons & Ms. Manavi Khurana, Founder of Karma Centre for Counselling and Wellbeing. Foundation has contributed 10 machines for the Prison Inmate Communication system and aims to benefit **106** male inmates inside Gurugram Prison, Haryana.

Project Second Chance



An initiative to provide released women with the much-needed support to start their lives afresh. This campaign aimed not only to empower women post-release from prison but also to create a crime-free society by significantly reducing the chances of recidivism. A total of 4 women beneficiaries enrolled themselves for the project. India Vision Foundation provided them with sewing machines and other raw materials so that they are enabled to become capable to lead self-reliant life with their abilities and skills. The monthly income of these women ranges from Rs. 2000-3000 at the least. An order of a total of **1196** was prepared by these beneficiaries which included mats, posters and napkins.

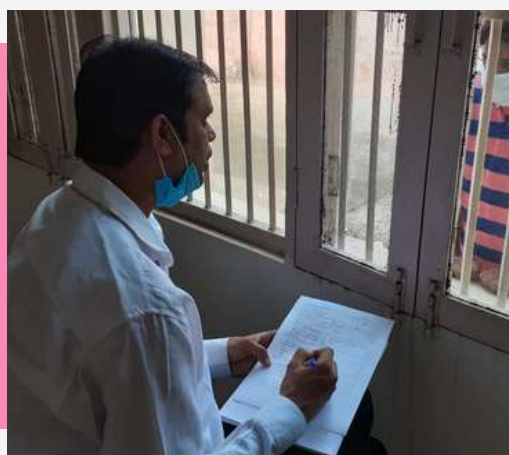


Project Saksham

A Pilot Project of 3 Months, that aims to support released inmates, their families, and families of prison inmates during pandemic through Ration support, counselling, awareness, legal aid and home visits, linkages to government schemes and Job opportunities; empowering them with education, build resilience towards crime through better coping skills for a dignified life after released. At present this pilot project is initiated with 60 released beneficiaries from Delhi, UP and Haryana Prisons.



Project Milaap



an initiative by the Foundation to support inmates of Faridabad and Gurugram Prison to re-establish links and reconnect with their family members during Covid-19 with the objective to facilitate mental wellbeing of inmates by catering to their emotional needs.

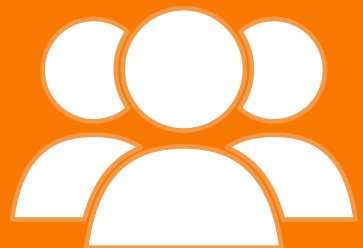
About

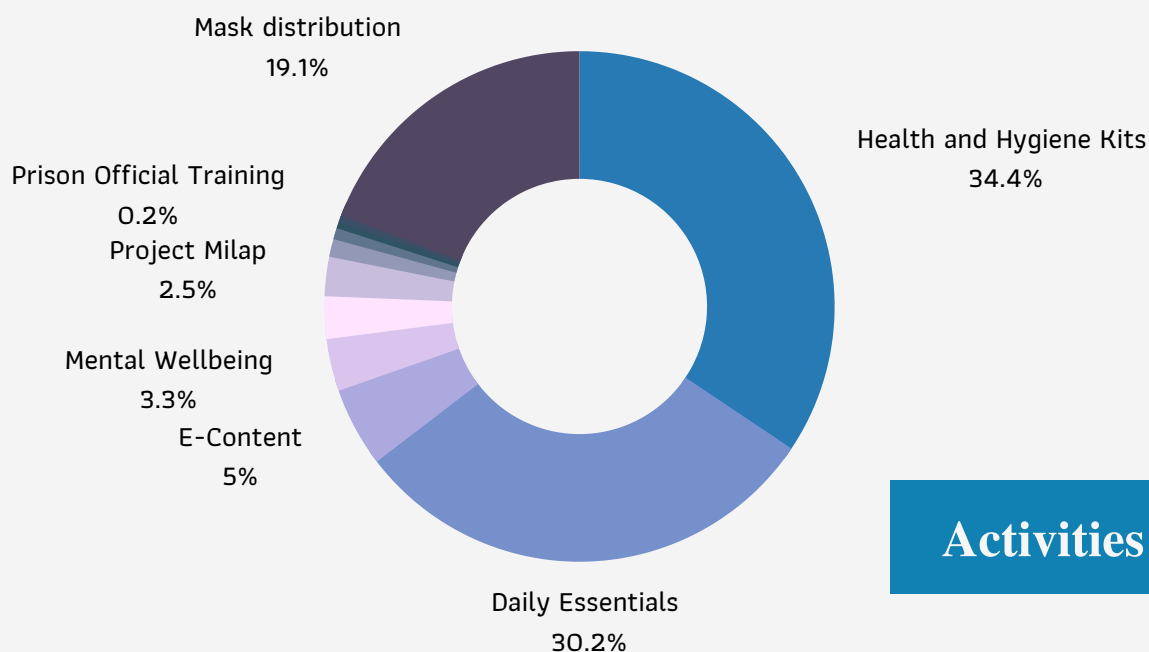

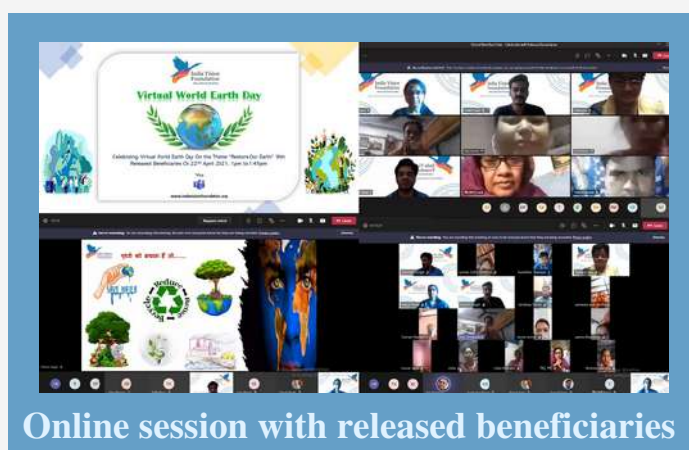
Team Upskilling & Training

Reeta Peshawaria-Menon Fellowship



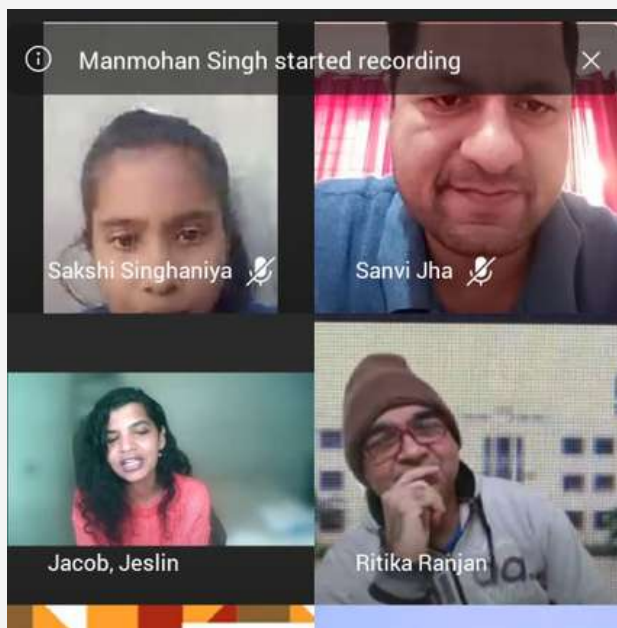
Reeta Peshawaria-Menon was Consultant Clinical Psychologist Lead at the Tertiary Assessment and Treatment Service of the Specialist Learning Disability Services at Hertfordshire Partnership NHS Foundation Trust, Hertfordshire, UK. She worked here from 2000 till her death in 2012. Before that, she had served as Senior Lecturer in Clinical Psychology at the National Institute for the Mentally Handicapped in Hyderabad for 16 years. The Fellowship award had been established by the family members of Ms. Peshawaria Menon to promote the values and practices she valued and stood for. The Award consists of a monthly bursary of a determined amount in Rupees to a deserving candidate for a maximum period of 12 months.

In this seventh year, thirteen applications were considered eligible. The Panel of experts constituted by the India Vision Foundation recommended that this year's award be given to Dr. Simi Shrivastava and Shivli Shrivastava for their study on Mindful Self-Compassion and Mental Health Wellbeing amongst Parents of Children with Autism Spectrum Disorder & Intellectual Disability. This Award comprise a Citation and Rupees One Lakh.

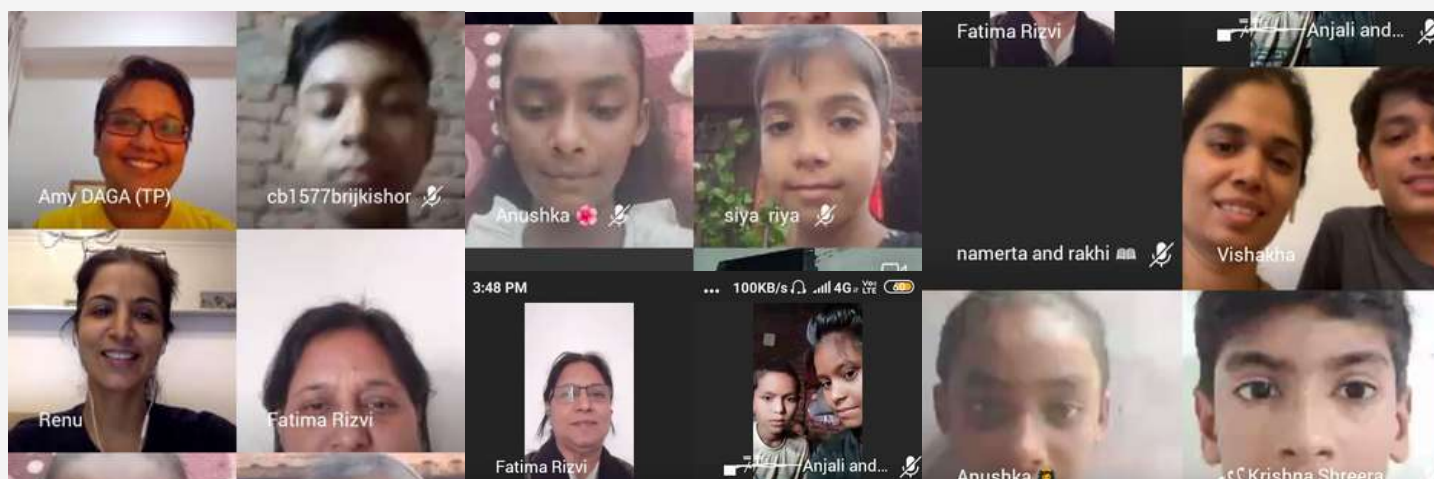

Navjyoti Balgurukul is a project by Navjyoti India Foundation to train marginalized children various skills and empower them by providing them knowledge across numerous fields. Balgurukul focusses on 3S – Shiksha, Sanskar and Skill.

Child education prevents vulnerable children from dropping out from mainstream education. Started in 1987 in the urban areas and in 1997 in the rural areas, this program grew out of a compelling need to break an inextricable relationship between loitering, rag picking, begging and out-of-school street children, with criminality such as drug peddling,

abuse, pick pocketing, child labor and other social evils. The project was initially started at the primary school level which later graduated towards the remedial component to ensure continuity in schooling. The Bal Gurukul project of Navjyoti India Foundation under Child education program aims to inculcate leadership and other skills amongst the children to become productive members of the society.

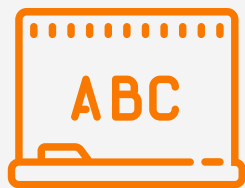


During the year 2020, amidst the coronavirus pandemic, the learning of students continued virtually by conducting classes on online platforms. Subjects like English, music, art and craft, computer etc. were taught to students over Zoom so that the pandemic did not hinder the learning of students.

in the last year Balgurukul conducted a total of 201 sessions on the following topics-



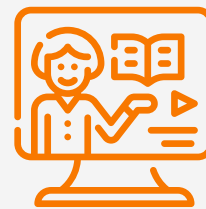

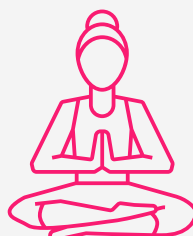

222.5 hours were spent in these online sessions, conducted by our enthusiastic volunteers, which greatly benefitted the children.

We also partnered with an online platform, Demonstrative Learning, which showcases the creative talents of children. In all 10 stories, 10 creatives drawn for stories and 10 paintings made by our students were chosen to be exhibited on the platform.

As a coalition partner of Womens World Summit Foundation (WWSF), Geneva we organised a 19 day Campaign on Prevention of Violence against Children and Youth from the 1st - 19th of November 2020 in association with District Legal Services Authority, Gurugram. The campaign aimed to sensitise community members on issues such as prevention of child sexual abuse and violence, neglect, corporal punishment etc. 4,776 students of Navjyoti participated in 3 sessions held under this campaign.

On the occasion of National Girl Child Day, Navjyoti India Foundation and India Vision Foundation organized an interactive session along with School of Education, GD Goenka University and District Legal Services Authority. 898 people attended and watched the session. Stories of changemakers who challenged social evils of society like dowry, education gap and child marriage, despite facing backlash, were shared and the changemakers rewarded with e-certificates for their achievements. The session ended with a beautiful thought by Ms. Saina Ruzbeh Bharucha who hopes to celebrate not just Girl Child Day, but also 'Life Day', where we celebrate each one of us and the life bestowed upon us.
